- a \$2.7 million verdict for a 20-year-old woman stranded for 10 days on a state highway;
- a personal injury settlement of more than \$1 million to compensate a man who was crushed between a tractor trailer and a loading dock;
- products liability litigation against a large national trailer rental corporation involving three deaths arising out of the use of a towing apparatus; and
- a number of settlements of more than \$1 million in cases involving products liability, professional liability, and auto and aircraft accidents.
